QUESTION ONE

Mr. Patela patriot who was educated by the Government of Kenya works as anassistant engineer for Quick-works Construction Company, a small construction company in Western Kenya.

The company has a contract to build a local hospital in Bungoma Town. During the course of his work, Mr. Patel comes across documents that suggest that Quick-works Construction Company has actually been bribing public officers in order to be considered in a tender. Mr. Patel is shocked. He knows this practice is unethical. And even though this was to the benefit of his employer, Quick-works Construction Companymay face criminal charges and suffer negative publicity. The practice was also making Quick-works Construction Company to over substandard services.

Mr. Patel gathers together the appropriate documents and takes them to his immediate superior, Mr.Wamalwa. Mr.Wamalwa says, "Look, I don't think that sort of thing is your concern, or mine. We are just employees in this company and Quick-works Construction Company is a beneficiary of this deal. For the sake of our jobs and the survival of the company, I suggest you drop this issue."

The next day, Mr. Patel decides to go one step further, and talk to Angela Nafula, the company's Operations Manager and the daughter of Bungoma county chief of staff. Angela is clearly irritated. Angela says, "This isn't your concern. Look, these is the only way a little company like ours can win tenders and compete with giant competitors. Besides, it is not illegal and everyone knows that this is what takes place in Kenya. You don't loose anything as an individual and you are not even a native of this country. I consider this matter closed."

Mr. Patelconsiders his situation. The message from his superiors was loud and clear. He strongly suspects that making further noises about this issue could jeopardize his job.
