QUESTION ONE

a. Supercabs limited which operates a fleet of taxis, engages Don as a driver. The company provides and maintains the taxi and pays for the petrol. Don promises to work only for the company. However, Don does not receive a wage but instead is paid a commission on the earnings he collects. The journeys he makes and the hours he works are left entirely to his discretion.

i.Discuss whether Don is in a contract of service or in a contract for service and distinguish between the two. (2 marks)

ii.Describe tests used to determine whether one is an employee or an independent contractor.

b.Distinguish between a bill of exchange and a promisory note.

c. The general rule is that judges should follow decisions made by higher courts. But at times the courts advocates for flexibility while deciding cases. Highlight cases when a lower court may depart from an earlier decision made by a superior court. (5 marks)

d.Argue the case for arbitration as a dispute resolution mechanism.

OUESTION THREE

a. There is a simple contractual relationship between the banker and customer . Its a debtor creditors relationship which imposes upon parties certain legally binding obligations. Explain the duties of the banker.
