- 1. George was arrested and charged with "Attempted Robbery". The Prosecution lined up THREE witnesses. Rose, Felix and William. Rose, who was the cashier, claimed that the defendant walked up to her holding a gun in his right hand and his index finger across his lips motioning for silence. Nonetheless, she was able to send a coded message to her husband who alerted the Police. Felix, who was a customer in the Supermarket claimed that he saw George brandish his gun in the air to scare shoppers into compliance; while William, the arresting officer reported that he met the defendant running out of the supermarket and detained him because he fit the description from the crime call; and that when he searched him, he found a handgun which was positively identified by witnesses 1 and 2 as the weapon they saw.
