- 1. Define the following terms
  - a) Meat pathology
  - b) Meat inspection
- 2. Briefly explain the following berms
  - a) ante mortem inspection
  - b) post mortem inspection
- 3. In meat pathology and inspection both ante mortem and post mortem are critical. Briefly explain why ante mortem inspection is essential
